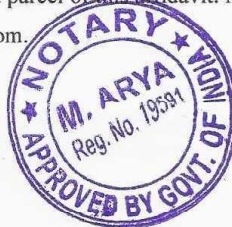



1. The application for Corporate Insolvency Resolution Process filed by IREDA Limited. (Financial Creditor) under Section 7 of the Insolvency and Bankruptcy Code, 2016 read with Rule 4 of Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules 2016 was admitted by **NCLT, New Delhi, Bench-II** vide order no **CP (IB) No. 360/ND/2021** dated 10.10.2022 (CIRP Commencement Date) wherein **Mr. Darshan Singh Anand**, the undersigned was appointed as Interim Resolution Professional who is directed to take necessary actions in accordance with the relevant provisions of the Insolvency and Bankruptcy Board of India Code, 2016.
