Will be part of any yatra that unites India: Ex-Army Chief

AMRITA NAYAK DUTTA NEW DELHI, JANUARY 10

FORMER CHIEF OF Army Staff (COAS) General Deepak Kapoor (left) is not new to controversies. Much of these were pushed back into the spotlight when the General, who led the Army between 2007 and 2010, joined the Rahul Gandhi-led Bharat Jodo Yatra on Sunday while it was passing through Haryana, along with other retired top officers of the defence services.



Former Army chief Gen Deepak Kapoor and retired defence personnel joined Rahul Gandhi in Bharat Jodo Yatra on Sunday.

When contacted, Gen Kapoor told the Indian Express that he does not want to comment on any allegations being levelled at him over the yatra. "But any yatra, which unites Bharat, is for it," he said. Commissioned into the Artillery Regiment in 1967, the decorated officer held several important commands and staff appointments in his 40-year-long tenure in the Army.

He took part in the India-Pakistan war in 1971 and Operation Parakram in 2001-2002, among other important military operations. But as Army Chief, Gen Kapoor ruffled feathers when he attended the single-stream pro-

motion policy for Major Generals and brought back a two-stream promotion policy that put officers into two different lists - those commanding troops and those holding administrative (staff) appointments - without listing specific criteria for doing so, as has since made the former better eligible for promotions compared to the latter. The decision, which led to massive heart-burn among officers in the force, remains in effect till date, despite his successors examining the matter, and the Armed Forces Tribunal holding it discriminatory. More recently, in 2017, Gen Kapoor along with another former Army Chief, General NC Vij, and other senior officers, was named by an inquiry committee set up by the Defence Ministry in the Adash Housing Society scam of Mumbai. The report, however, mentioned that Gen Kapoor was not directly connected with the case and hence not advised of hearing becoming a member of

the society, which was meant for families of Kargil heroes. The same year the former Army Chief found himself in another controversy when, during a election speech, Prime Minister Narendra Modi alleged Pakistan's interference in Gujarat elections referring to a dinner meeting hosted by Congress leader Mani Shankar Aiyar at his residence. Gen Kapoor was present at the meeting.

In 2019, he was among a group of over 100 veterans who signed a letter sent to then President Ram Nath Kovind, stating that political parties should not use the military to further their political agenda. However, on matters such as India's response to China in the ongoing border standoff at the line of Actual Control, Gen Kapoor has appreciated the government's actions, telling that India had given an excellent firm response to Chinese aggressions.

As Rahul visits Golden Temple, Oppn invoke 1984 to attack him

Congress leader Rahul Gandhi offered prayers at the Golden Temple in Amritsar on Tuesday, sparking sharp reactions from opposition parties in Punjab who targeted his party over the 1984 anti-Sikh riots. At the Golden Temple, Gandhi did not receive any official welcome from the Shriromani Gurdwara Parbandhak Committee, which usually honours dignitaries at the information office. The SPCPC, meanwhile, said the Congress leader should have tendered for "attack on Akal Takht" in 1984. Gandhi arrived at the Amritsar airport in the afternoon after concluding the Haryana leg of the Bharat Jodo Yatra. He will start the Punjab leg of his Yatra Wednesday.

Sporting an orange turban, the former Congress chief paid obeisance at the sanctum sanctorum of the Golden Temple. "By reaching Sri Harmandir Sahib, the faith in humanity becomes even deeper. Shri Akal" he said in a tweet in Hindi. Gandhi also posted a few pictures on Twitter, where he is seen taking "parshad" and listening to "garbani" during his Golden Temple visit.

He was accompanied by Punjab Congress chief Amrinder Singh Raja Warring, Leader of Opposition in the Punjab Assembly Partap Singh Bajwa, local MP Gurjit Singh Aujla.
