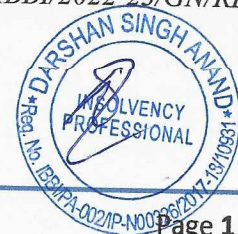


**Notes:**

Accordingly, any objection to inclusion or exclusion of a prospective resolution application in the provisional list may be submitted on or before 08<sup>th</sup> January 2023.*
  - The Information Memorandum, Evaluation Matrix, RFRP along with the access to Virtual Data Room will be shared with the PRAs, on 23<sup>rd</sup> January 2023\*.*
