

১৯-এ কুশ্চি কার, পাঁচ রাজ্যের ফলাফল দেখে এখনই বলা কঠিন

পাঁচ রাজ্যের নির্বাচনের ফলাফলে প্রত্যাশিতভাবেই জনমত প্রাতফালত হয়েছে। এমনটা যে হতে চলেছে তা বিভিন্ন সংবাদমাধ্যম এবং আগাম এক্সিট পোলে তার পূর্বাভাস দেওয়ার হয়েছিল। কিন্তু পাঁচ রাজ্যের ফলাফলে বলে দেওয়া সম্ভব নয়, ২০১৯ সালের সাধারণ নির্বাচনে কি হতে পারে কেন্দ্রে। কারণ এটা বিধানসভা ভিত্তিক ফল। কখনই এই ফলাফলে সর্বভারতীয় ক্ষেত্রে প্রযোজ্য হয় না। তবে বিজেপিকে বুঝতে হবে জনতা-জনাদেশ শেষ কথা বলে। এই পাঁচ রাজ্যের ফলাফল প্রধানমন্ত্রী নরেন্দ্র মোদীর বিরুদ্ধে ভোট না প্রতিষ্ঠান বিরোধী অথবা প্রতিষ্ঠানের স্বপক্ষে ভোট, তার পূর্বাভাস এত আগে দেওয়া যায় না আবশ্যই হিল ভাষাভাষী তিনি রাজ্যে কংগ্রেসের শক্তি অনেক বাড়ল, বাড়ল দলের সভাপতি রাখল গান্ধির ভাবমূর্তি এবং প্রহণযোগ্যতা। পাঁচ রাজ্যের মধ্যে হিন্দি বলয়ের এই তিনি রাজ্য হল মধ্যপ্রদেশ, রাজস্থান, ছত্তিশগড়। বাকি দুটির একটি মিজোরাম অপরাজিতে তেলেঙ্গানা। মধ্যপ্রদেশে গত কয়েক বছর ধরে একের পর এক কেছু হয়েছে। পাশাপাশি বিক্ষুল হয়েছেন চাবিরা খণ্ড মকুব, ফসলের ন্যায্য দাম এবং অন্যান্য ইস্যুতে। মুখ্যমন্ত্রী শিবরাজ সিং চৌহান কৃষকদের দাবি দাওয়ার প্রতি যতটা সহনুভূতিশীল হওয়া উচিত ছিলেন তা তিনি হননি। ফলে কৃষকদের মধ্যে ক্ষেত্র ক্রমশ বেড়েছে। এর উপর দলিলদের উপর নানা অত্যাচারের ঘটনায় সরকার কার্যত নিষ্পত্তি দিল। সবচেয়ে বড় কথা ক্ষমতার দণ্ডে মানুষের নাড়ি টিপে দেখার কথা কখনও তিনি ভাবেন নি। তিনি নির্ভর করেছেন আমলাদের রিপোর্ট এবং রাজ্য পুলিশের গোয়েন্দা রিপোর্টের উপর। এর উপর নিজের রাজ্য কংগ্রেসের শক্তিকে কোনও গুরুত্ব দেননি মুখ্যমন্ত্রী। বরং রাখল গান্ধির বক্তব্য নিয়ে ব্যঙ্গ করা হয়েছে। পাশাপাশি ছিল বিজেপির প্রবল গোষ্ঠীদন্ড। সব মিলিয়ে মানুষ শিবরাজ সিং সরকারকে চায়নি। রাজস্থানে যে এমন ফলাফল হবে তা নির্বাচনী প্রক্রিয়া শুরু হওয়ার পর থেকেই শোনা যাচ্ছে। প্রথমত রাজস্থানে একবার বিজেপি, একবার কংগ্রেস এইভাবে সরকার বদল হয়। দ্বিতীয়ত মুখ্যমন্ত্রী বসুন্ধরা রাজে সিন্ধিয়ার অস্তিত্বের দণ্ড, মানুষকে কীট-পতঙ্গ মনে করা, সর্বপরি জাত-পাতের রাজনীতিকে তুলে ধরা সব মিলিয়ে তাঁর সরকারের পতন ঘৰায়িত হয়েছে। যদিও নির্বাচনে তিনি জয়ী হয়েছেন কিন্তু মানুষ প্রতিষ্ঠান বিরোধী ভোট দিয়েছে। যাকে বলা হয় অ্যান্টি ইনকামবেলি ছন্দশিগড়েও একই হাল। প্রধানমন্ত্রী নরেন্দ্র মোদীর স্বেচ্ছাজন মুখ্যমন্ত্রী রমন সিংহের

তেলেঙ্গানায় কোসভার ফিরে এলেন ফের ক্ষমতায় তা অনেকটাই প্রত্যাশিত ছিল কারণ তাঁর প্রশাসনিক দক্ষতা, মানুষকে নিয়ে কাজ করার অভিজ্ঞতা রয়েছে। ইউপিএ সরকারের আমলে প্রথম দফায় অনেক রাজ্যেই বিজেপি ক্ষমতায় ছিল কিন্তু কেন্দ্রে বিজেপি সরকার হয়নি। ড. মনমোহন সিংহের নেতৃত্বে কেন্দ্রে কংগ্রেস নেতৃত্বাধীন জোট সরকার ১০ বছর শাসন ক্ষমতায় থেকেছে। সে সময় পশ্চিমবঙ্গে বামফ্রন্ট সরকার ছিল ক্ষমতায়। ত্রিপুরায় এবং কেরলে বামদের আধিপত্য বজায় ছিল কিন্তু ২০১৪ সালের লোকসভা নির্বাচনে দেখা গেল মোদী ঝড়ে সব ওলেট-পালেট নয়ে শিয়েছে। এন্টিএ সরকার প্রাণ্যাত প্রের অনেক ইস্যুতে যান্ত্র সমাজলোকে


