Receipt of complaint has been Centralised. Complaint against an RE can be filed through one of the following modes:

- Online - through the Complaint Management System (CMS) portal of RBI on <https://cms.rbi.org.in> → File a complaint
- Physical complaint (letter/post) in the form as specified in Annexure 'A' in the RB-IOIS to "Centralised Receipt and Processing Centre, 4th Floor, Reserve Bank of India, Sector -17, Central Vista, Chandigarh – 160017"

He said more than 500 start-ups have been set up for millet products. Farmers' organisations and self-help groups are also coming forward in this direction, he said.
